

**RMB Virtual Card First-Time User  
CAMPAIGN RULES**

Read these Campaign rules carefully. These Campaign rules (“rules”) explain your rights and duties in connection with this Campaign. <b>Promoter(s) Name(s):</b>	This Campaign is run by RMB Private Bank a division of FirstRand Bank Limited with Reg. No. 1929/001225/06 having its principal place of business at No 5, Merchant Place, 9 Fredman Dr, Sandown, Sandton. In these rules reference to “promoter(s)” or “the promoter(s)” or “us” or “we” means FRB. Reference to “participants” means “you” and subject to the terms, conditions and the rules as set out below.
<b>The Campaign Offers:</b>	<ol style="list-style-type: none"><li>1. Selected customers in the Campaign, will receive an APN (App Push Notification) message on the RMB Private Bank App.</li><li>2. The selected customers have never spent on an RMB Private Bank Virtual Card and must use / spend on their RMB Private Bank Virtual Card/s (Credit Card, Debit / Fusion Card) to qualify.</li><li>3. The selected customer must spend on their RMB Private Bank Debit, Credit or Fusion Virtual Card within 30 calendar days from receipt of the APN (App Push Notification)</li><li>4. The first 10,000 customers who have spent with their RMB Private Bank Virtual Card/s will receive a R100 cashback into the account linked to the Virtual Card where the purchase was made from within 7 working days after the virtual card transaction is made.</li><li>5. <p><b>Eligibility:</b></p> <p><b>Who qualifies to take part?</b></p>	<ul style="list-style-type: none"> <li>• Existing RMB Private Bank Credit Card, RMB Private Bank Fusion and RMB Private Bank Debit card customers who receive the App push notification will be eligible to participate</li> <li>• These selected customers have been determined as customers who have opened RMB Private Bank Credit, RMB Private Bank Debit or RMB Private Bank Fusion accounts but have not made use of their Virtual Cards before.</li> <li>• You are a natural person over the age of 18.</li> <li>• You are in possession of your valid South African ID book or valid passport for identification purposes.</li> <li>• Your account/s is in good standing. This means that none of your RMB Private Bank and FirstRand Bank accounts and credit agreements should be overdrawn, or be in arrears, or be in default, or be subject to any legal process with RMB Private Bank or FirstRand Bank. ## **IMPORTANT**
